Minutes Last Meeting:

Kathy reported that West Tennessee fundraising in 1982, although not a loss, was insufficient to adequately support the Chapter. The Memphis office depends on raising enough money to support it.

This year a State plan has been designed to divide the year into quarters during which a particular activity, such as membership drive, Chapter fundraising, large donor drive, is emphasized.

Mary Wilder moved and Bruce Kramer seconded a motion that the West Tennessee Chapter have a combination Art Auction and Winefasting Event and that a committee be appointed to plan and organize this event. Passed unanimously.

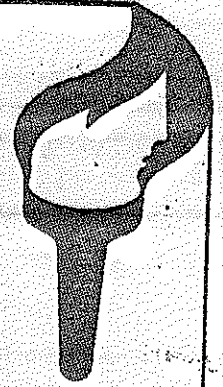

Membership Meeting and Board Election:

Mary Wilson moved and Rodney seconded that the Chair appoint a committee to organize the February meeting as a membership meeting and election of the Board. Passed unanimously. It was suggested that the committee investigate the possibility of combining the meeting with the Legislative Workshop on Saturday, February 12, 1983.

The National Office has changed its policy on sharing the fees with Chapter members it recruits. There will be no sharing the first three (3) years and a 70/30 split after that. The West Tennessee Chapter needs to recruit more members to increase the ability to get funds.

Legal Committee:

The following recommendations were made on cases from the Legal Committee:

1. A suit against Shelby County Jail for holding arrestees without charge. Accepted.
2. A suit against Memphis Police Department for wrongful arrest on disorderly conduct charge. Rejected. Not strong plaintiff.
3. A suit against various officials in McKenzie, TN for conspiracy and other violations on behalf of the Nazi Party. Rejected. Related to criminal charges, not pure 1st Amendment issues.

Bill of Rights Lobby Workshop: February 12, 1983, probably at the Main Branch of Memphis and Shelby County Library.
